VERIFICATION PROCESS DEPENDENT

Verification? What is it?

The Department of Education selects some students to complete the verification process. The information you & your parent provide is cross-checked with your FAFSA information to ensure that FAFSAs are correct.

Financial Aid Advisors CANNOT process any financial aid for selected students until this process has been completed.

The Verification Process is an online process for students and parents of dependent students. Please read below for some advice on completing the process.

I think I was selected. How do I get it started?

Students can begin the process by reviewing the Outstanding Requirement letter you received in your Mylvy email (subject: Important Information About Your Ivy Tech Financial Aid File) It contains instructions for completing each required piece of the verification process, as well as links to any forms you will need to fill out and/or sign.

I have to submit income information, what do I do?

Some students and parents may be required to provide income information.

- A)If you completed 2023 federal income taxes, you can provide tax information by completing one of the following:
 - 1)Obtain a signed copy of your and/or your parent's filed 2023 IRS Form 1040; OR
 - 2) Request your 2023 Federal Tax Return Transcript, or ask your parent to request their transcript, from the IRS at www.irs.gov/Individuals/Get-Transcript or visit the Enrollment Center for assistance.
- B)For non-tax filers, the Missing Information email will contain your documentation requirements. Those will include your and/or your parent's W-2 documents for any income earned from work in 2023.
- C)Scan your required documents (signed forms, tax and earnings documents, family size forms, etc.) to your computer/jump drive. Upload your documents by clicking on your home campus's Secure Financial Aid File Drop (https://www.ivytech.edu/tuition-aid/financial-aid/managing-your-financial-aid/financial-aid-forms/secure-financial-aid-file-drop/).

D)If you filed an amended tax return or have an extension to file, please ask for instructions at your Enrollment Center or call 888-IVY-LINE.

My missing information email shows that I have other documents to submit, what do I do?

You can submit other requirements by clicking on each separate link and following the instructions in the Outstanding Requirements email (you can scan and upload them as described above).

When all requirements have been completed, your file will be reviewed in the order it was received. This may take up to 14 days.

The financial aid office will not take ANY documents from students unless the students are sent a specific message instructing them to do so.

If you submit documents to the financial aid office and have not been instructed to do so, all documents will be returned to you, potentially delaying the processing of your aid.
